

## Risk Disclosure | Behavioral Rules | Waiver for Diving Tower Over 10 Meters

### GENERAL BEHAVIORAL RULES AND RISK DISCLOSURE

#### Risk Disclosure – Personal Responsibility

Due to my complete physical and mental health and my sporting experience, I consider myself capable of properly assessing the **high diving from over 10 meters** and all associated risks.

A basic requirement for high diving is **physical and mental health, surefootedness, being free from severe a fear of heights, and good swimming skills**. By registering and signing, the participant confirms that they possess these abilities/requirements.

I am aware that high diving is demanding and carries various sport-specific risks. The risks may arise from (but are not limited to) the forces of acceleration acting on the body, the risk of falling, natural hazards (including the risk of drowning), disregarding instructions, misbehavior by the participant or other involved parties, and common risks associated with practicing the sport (e.g., spraining an ankle, slipping, etc.). High diving involves high speeds and fall heights, and controlled entry into the water is not always possible (risk of injury!).

The realization of these risks can lead to severe injuries, including death, pain, emotional stress, trauma, property damage, financial losses, etc. These damages can affect not only myself but also other involved parties (AREA 47 and their employees, other participants, other service providers, spectators, insurance companies, etc.). I acknowledge that hazards from external persons (e.g., other users of the Water AREA) cannot be ruled out.

**I have been informed of all these risks and accept full responsibility for them.**

#### Minimum Age, Physical and Mental Condition

I am over **18 years old** (or participating with the consent of my guardian; **minimum age: 14 years**), in good physical condition, **not pregnant**, and not under any physical or mental influence that could impair my judgment and performance - I am particularly not under the influence of alcohol or drugs.

#### Compliance with Instructions and Applicable Rules

I will unconditionally follow all instructions from AREA 47 employees. Furthermore, I will carefully read the information boards and signs in the Water AREA and behave accordingly, as well as adhere to the applicable behavioral rules.

No liability will be assumed for property and personal damages resulting from non-compliance with such instructions. No liability will be assumed for the loss or damage of personal valuables, glasses, contact lenses, watches, cameras, etc.

#### Medical Assistance

I am also aware that there is no doctor among the employees of AREA 47. In case of an accident, rescue/paramedics must first be notified. I will bear the costs of my initial medical treatment, nursing care, and further assistance myself. It is recommended to take out accident insurance with appropriate coverage.

### WAIVER OF LIABILITY, INDEMNITY, AND HOLD HARMLESS

Being aware of all the circumstances of high diving and assuming all risks, I hereby waive – also on behalf of my legal successors – any liability towards AREA 47 Betriebs GmbH, Ötztaler Achstraße 1, 6430 Ötztal Bahnhof, the companies associated with AREA 47, their vicarious agents, as well as their representatives and employees. This waiver does not apply to personal injuries caused by the aforementioned persons through negligence, or to property damage caused by gross negligence or intent, as well as to damages compensable under the Product Liability Act.
